There have been several recent incidences of fly tipping in the area and concerns Cheshire East Council have not set an amount for Fixed Penalty Notices to be issued.

Resolved to send a letter to Councillor Laura Crane (Cabinet Member for Highways and Waste) to address this and raise concerns over proposals to close some Household Waste Recycling Centres.

### 6. TO DISCUSS GRITTING BINS

Gritting routes are being reviewed and from next winter the Moston lanes may not be gritted. Cllr Nixon has ensured the 3 gritting bins currently in place are registered and so will be topped up by Cheshire East on an annual basis. The council will revisit this issue next Autumn and may need an additional bin on Plant Lane near the canal bridge

### 7. TO RECEIVE AN UPDATE FROM THE MEETING ABOUT GLEBE FARM

Councillors Brooker, Harrop, Nixon and Roscoe attended a recent meeting with Middlewich Council and Taylor Wimpey to discuss Glebe Farm, Moston which has outline planning permission for 450 houses with access roads on Warmingham Lane and Booth Lane. Issues of concern included the impact of increased traffic on local roads both during and after construction. It was positive to be able to work with Middlewich and Moston Parish Council hope this will continue

Morgan Road, Albion Lock is not a through road. Road signs do not indicate this and there is an issue with traffic attempting to exit the estate from Morgan Road via Boyd Close then having to turn round, causing damage to gardens and the grass verge. Resolved to purchase a No Through Road sign if ongoing dialogue with Taylor Wimpey does not reach a sensible solution.
